UNGA Conference 2021 aims to contribute to the IEP's Positive Peace Pillars by:

- 1. Creating a civil society platform to debate on the UN Global Agenda 2030 and facilitating a free flow of information with the Conference Proceedings;
- 2. Contributing to the well-functioning of the UN Member States for the political stability and the rule of law;
- 3. Sharing inclusive policies to create diverse societies by promoting formal laws and informal social and cultural norms to protect the human rights of all;
- 4. Promoting the right to access inclusive and equitable quality education for all in the Post-COVID19 Era to resolve the substantial setbacks of the pandemic and increase high levels of human capital through digital technologies;
- 5. Developing local, national, global strategies, and gender-sensitive policy recommendations to combat the crisis posed by climate change and ecological threats.

Expected Outcomes

- 1. Adoption of the Declaration and Proceedings of the UNGA Conference 2021;
- 2. Development of an action plan framework to be implemented by the Conference stakeholders;
- 3. Follow-up action items on quality education, climate change, global partnerships for the Sustainable Development Goals;
- 4. Recognition of outstanding civil society leaders and organizations contributing to sustainable peace and development while promoting the culture of peace, diversity, human rights, women, and youth empowerment at the local, national, and global levels.

Background

The UNGA Conference is the flagship event of the JWF, creating a platform for diverse stakeholders to discuss the Global Agenda 2030, offer innovative solutions, strategies, and policy recommendations to advance further the culture of peace, human rights, and sustainable development. Every year, this global event gathers an interdisciplinary group of distinguished panelists and high-level speakers to discuss a particular agenda around the three subsequent panel sessions and propose a framework for action.

The successful implementation of SDG #17: Partnerships for the Goals remains at the center of the UNGA Conference 2021 as the SDGs can only be implemented with strong global partnerships and cooperation. The SDG 17 is focused on the UN rallying together strong partnerships in achieving all the Global Goals. The JWF has contributed to this goal by mobilizing its Global Partners in sharing best practices and initiating peoplecentered policy suggestions on the achievement of the UN Development Agenda 2030.

The action-oriented 2030 Agenda for Sustainable Development has encouraged all stakeholders, including UN Agencies, Member States, the private sector, civil society actors, and experts to bridge the gap between policy and knowledge while creating interlinkages between them the goals and accelerate the implementation progress of the SDGs. This year, 2021, still represents the critical turning point for our global community which has been combatting the COVID-19 Pandemic. The challenges posed by his global health crisis enabled our international community to redefine economic and social development while following new trends of methodologies and policy implementations.

PANEL 1 - PROGRESS OF SDG #17: PARTNERSHIPS FOR THE SDGS

With less than a decade left to achieve the SDGs, partnerships at all levels are essential for implementing the Global Goals and mobilizing national commitments, efforts, resources, and technology.

The 2021 ECOSOC Forum "Partnerships as Game Changer for a Sustainable Recovery from COVID-19" underlined UN Secretary-General`s urgent call for the following efforts to accelerate the recovery processes by (i) taking coordinated actions at the global level to suppress the pandemic, including by supporting the health systems in countries that are most at risk; (ii) promoting comprehensive responses to tackle the devastating socio-economic consequences, focused on the most vulnerable countries and peoples; and (iii) building back better with a view to ensuring sustainability and resilience. Multi-stakeholder partnerships require different sectors working in collaboration by mobilizing their financial resources, assets, knowledge, and expertise. Besides the intergovernmental agencies` development policies, socially responsible corporates` and civil society`s best-practices are essential in accelerating national, regional, and subnational partnerships for the implementation of the SDGs.

Despite the urgent need, the recent UN DESA Report on "The Impacts of COVID-19 on Stakeholder Engagement for the SDGs" indicates that "stakeholder engagement is at risk of falling away in the face of key challenges". One of the most prominent challenges highlighted in the report is that there is a missing framework of an accurate alignment between the local, national and recovery plans. The UN DESA's studies underline that "a recovery plan that is actively aligned to a holistic, comprehensive account of the 2030 Agenda" is essential to build back better.



PANEL 2 – CLIMATE CHANGE AND ECOLOGICAL THREATS



The setbacks during the COVID-19 caused a reduction in the ongoing environmental damage, only in the short run. Climate change and ecological threats are still posing a great risk to the timely achievement of the SDGs. The targets of the Paris Agreement are still off track. According to the progress report of the SDG 13: taking urgent action to combat climate change, "in order to limit warming to 1.5°C above pre-industrial levels as called for in the Paris Agreement, global efforts would need to reach net zero CO2 emissions globally around 2050".

On the other hand, the Institute for Economics and Peace's Ecological Threat Register (ETR) underlines that ecological threats should be addressed separately. Even though it is a related area of concern with climate change, the ETR 2020 Policy Seminar Document highlights that ecological threats such as water scarcity, food security, and many types of natural disasters exist regardless of the climate change crisis. Experts indicate that "the number of ecological threats resulting in geopolitical

issues will increase over the next 30 years, causing the nature of conflict to become more connected with ecological insecurity". Ecological threats inevitably impact the peacefulness of the states as mass displacement, enforced migration wave and extreme poverty causes regional conflicts.



The climate change crisis and ecological threats unequally impact women and children especially in situations of poverty and limited access to scarce resources. Women and

girls are still included in the world's poorest and most vulnerable groups and they continue to face the environmental, economic, and social costs of climate change. As in all areas of socio-economic development, women's meaningful participation in climate-related response mechanisms creates a long-lasting positive impact. Their local knowledge, sustainable resource management, community and national leadership make women great decision-makers to resolve conflicts posed by climate change and ecological threats.

PANEL 3 - QUALITY EDUCATION IN THE POST-COVID ERA AND DIGITAL TECHNOLOGIES

HAS WIPED OUT 20 YEARS OF EDUCATION GAINS


AN ADDITIONAL 101 MILLION OR 9% OF CHILDREN In Grades 1 Through 8 Fell Below Minimum Reading Proficiency Levels in 2020 All the Global Goals are interrelated and dependent on each other. SDG4 "ensuring inclusive and equitable quality education and promoting lifelong learning opportunities for all" has a remarkable contribution to the implementation of the Global Agenda 2030. One of the critical areas that the COVID-19 Pandemic has caused a substantial setback is access to education.

The progress report of the Department of Economic and Social Affairs on sustainable development identifies the long-term implications of unequal access to education during the pandemic as a "generational catastrophe". As one of the most crowded public places, schools were among the institutions that are closed for in-person access all around the world. However, this health precaution created unprecedented consequences for the social wellbeing of children and impacted their learning trends. An increased number of children may never have a chance of returning to school as they are forced into child labor or child marriage. The progress report also indicates that "an additional 101 million children and youth (from grades 1 to 9) fell below the minimum reading proficiency level due to COVID-19 in 2020, which wiped out the education gains achieved over the last 20 years".

The 59th Session of the Commission for Social Development (CSocD) highlighted "The Role of Digital Technologies on Social Development and Well-being of All". Stakeholders indicated that a global unity and collaboration facilitated using digital technologies is required as COVID-19 reversed a decade of action. To lower the disparities among the most vulnerable, the CSocD Chair Ambassador Ms. María del Carmen Squeff of Argentina underlined that there is an increased "urgency of closing the digital gender divide to ensure that women and girls benefit equally from the opportunities available online".

PIONEERS IN SDGS AWARDS: CALL FOR PROJECTS

Pioneers in SDGs Awards pay tribute to outstanding individuals and organizations who contributed to sustainable peace and development while promoting and protecting the culture of peace, human rights, and sustainable development at the local, national, and global levels. The Journalists and Writers Foundation and its Global Partners recognize Pioneers in SDGs that help achieve the United Nations Sustainable Development Goals (SDGs) by implementing innovative and creative projects benefiting local communities. The altruism, philanthropy, dedication, and commitment of the Pioneers in SDGs are worthwhile in making our world a better place for all.

Our international jury will evaluate the projects based on four criteria: innovation, stakeholders, scope, and impact, including but not limited to community service, dedication, philanthropy, and uplifting the society. After quantitative and qualitative review of the projects, the international jury will select the first, second, and third place winners from different countries around the world. In previous years, 21 projects from 15 different countries were awarded for their outstanding contributions to their local communities. This year, Pioneers in SDGs Awards Ceremony will be held on 15 September 2021, a week before the UNGA Conference 2021.

Global Visibility & Recognition

Pioneers in SDGs participants will have the remarkable opportunity to share their best-practices and projects with an influential audience from the United Nations diplomats, academics, experts, journalists, and more. In addition, projects and videos will be promoted on the UNGA Conference website for international exposure and compiled as a booklet for distribution to relevant United Nations agencies. Pioneers and organizations will benefit from meeting and networking with international organizations and exploring opportunities for further collaboration and partnership.

Submission & Evaluation

The Selection Committee will evaluate each project considering four criteria: innovation, stakeholders, scope, and impact. The projects are expected to serve as an exemplary model that can inspire other individuals and organizations to make a positive social change and contribute to the UN Sustainable Development Goals.

Projects can be submitted at the UNGA Conference website that includes project application, a three-minute video, contact information, and a description of the project. Details about the Call for Projects are available at https://unga-conference.org/call-for-projects/

The deadline is September 1, 2021.



PIONEERS IN SDGS AWARDS

Selection Criteria

- 1. **Innovation** refers to the project's approach to finding creative solutions to global challenges. The project will be assessed on a scale from 0 to 25 for innovative contributions to social, economic, and environmental development.
- 2. **Stakeholders** refers to key players involved in the decision-making processes. The project will be assessed on a scale from 0 to 25 for inclusiveness in the decision-making processes without discriminating on basis of race, ethnicity, gender, etc.
- 3. **Scope** refers to planning, implementation, and evaluation processes. The project will be assessed on a scale from 0 to 25 for goals, objectives, indicators, and outcomes with tangible results.
- 4. **Impact** refers to the contributions of the project on individuals, organizations, and the society at large. The project will be assessed on a scale from 0 to 25 for impact in society in regard to social, economic, and environmental development.

Ms. Parnes started her career in Social Affairs as a volunteer of the Welfare Israelite Brazilian Union, one of the oldest organizations of the civil society which cares of children, teenagers, older people, and families. H.E. Ms. Markova Concepción Jaramillo, Permanent Representative of Panama to the UN, Permanent Mission of Panama to the United Nations | PANAMA



Ambassador Markova Concepción presented her credentials in November 2020, as the Permanent Representative of Panama to the United Nations. Ms. Concepción Jaramillo had been the Minister for Social Development since 2019 and presided over the National Council for Gender Parity. From 2014 to 2019, she served as Director of Social Development of the Business Association Sumarse-Pacto Global Panamá, which promotes corporate social responsibility.

She is an Economist with a MA in Gender and Development from the University of Panama. She has two postgraduate degrees in Training in Economic Research and Organization Management and in Virtual Learning Environments. Ambassador Markova Concepción was appointed as National

Planning Director in the Ministry of Social Development and the Public Ministry. She served as the Coordinator of Monitoring and Evaluation of the Justice Improvement Program of the European Union in the Judicial Branch.

Ambassador Markova Concepción facilitated courses on design of public policies of the Center for Public Policies and Transparency of the University of Panama sponsored by the Development Bank of Latin America and the George Washington University, DC. She was a member of the Advisory Council of the Observatory for the Rights of Children and Adolescents of Panama (ODENA) in 2017 and 2018. She received recognition from the Attorney General's Office of the Republic of Panama and the United Nations Development Program in the Results-Based Management Course. Sydney.

Sarmad Khan is an international affairs professional with over 20 years' experience in United Nations development cooperation, international policy and programmes and executive leadership development. Mr. Khan has held several senior positions in the United Nations, most recently as the Head of the UN RC Office in the UAE, Senior Advisor on Planning and Partnerships, and Special Advisor on the UN's engagement in Expo 2020, Dubai.

He was Head of leadership policy and programme development at the UN Development Operations Coordination Office where he led UN's work on leadership solutions and reform. He served as one of the lead authors of the UN's first Leadership Model promoting systems leadership, a member of

the senior UN committee charged by the Secretary-General to develop a system-wide leadership framework, and senior manager of the UN's first high-level 'Learning Advisory Council on the 2030 Agenda'.

Earlier in his career, Sarmad worked with the United Nations System Staff College in Turin as an Instructor and Coordinator of its flagship UN Leadership Programme training senior and emerging leaders across the UN system. Long Term Implications of an Unequal Access to Education During COVID-19



Prof. Seara-Vazquez studied law at the University of Madrid and took his doctorate in International Law of the Université de Paris (Sorbonne) with a pioneering thesis on the law of outer space. Modesto Seara-Vázquez has dedicated 72 years of his life to academia in UNAM and in the State University program in Oaxaca. He is considered one of the founders of outer space law in the late 1950s and has contributed original ideas to the development of the disciplines of international law and international relations.

As Rector of the Oaxaca State University System, he constantly tours the different campuses. He continues to publish scholarly works and regularly participates in national and international academic conferences, as well as lecturing in Mexico and other countries. Prof. Seara-Vazquez has published more than thirty books and pamphlets and scores of contributions in academic journals and newspapers on international issues, mainly in the fields of law, politics, history, and international relations theory, always from a global perspective.
